The journal allows researchers to publish impactful research in a timely manner. While the focus of the journal remains on addressing the public sector and governance issues, development in the research and policy landscape dictates the need for a multidisciplinary approach. The reach of the journal has continued to grow in various ways. The number of countries of origin for the submissions has increased. The rolling average shows that 20% of the submissions have come from outside South Africa, including various African countries, France, the United Kingdom, India and Australia. Furthermore, the country's research focus is also widening, making the journal content more relevant.

The journal continues to grow and have an impact beyond South Africa. Our rolling average ensures that 20% of our articles originate from outside South Africa and include various African countries, including France, the United Kingdom, Australia, India and China. Moreover, the institutional footprint within South Africa has also increased. The articles in this issue include articles from 15 South African universities, showing the growing reach of the journal and its growing importance and it shows that researchers recognize the impact the journal has on our readers.

The journal has continued to accept special issues. In 2021, the journal published a timely issue on the effects of the COVID-19 pandemic, highlighting the challenges posed by the pandemic and the responses of various public service entities. We are also excited to announce that we will publish a special issue on socioeconomic transformation in 2023.

The journal has made a concerted effort to ensure timely feedback to the authors. We are grateful to all our reviewers who have helped us to ensure that the double-blind review process used by the journal remains rigorous.
